General Information

Within the scope of Article 11 of the Personal Data Protection Law ("**KVKK**") numbered 6698, everyone has the right to make an application to the data controller, İmren Plastik Sanayi Ve Ticaret Limited Şirketi ("**Company**") on the following matters:

- a) To learn whether personal data is being processed,
- b) To request information if personal data has been processed,
- c) Learning the purpose of processing personal data and whether they are used appropriately for their purpose,
- d) To know the third parties to whom personal data are transferred domestically or abroad
- e) To request correction of personal data in case of incomplete or incorrect processing,
- f) In accordance with Article 7 of the KVKK, to request the deletion or destruction of personal data within the framework of the stipulated conditions, either ex officio or upon the request of the person concerned, in the event that the reasons for the processing disappear, although it has been processed in accordance with the provisions of the KVKK and other related laws,
- g) Request notification of the transactions made pursuant to subparagraphs (e) and (f) to third parties to whom personal data have been transferred,
- h) To object to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- i) To request the compensation of the damage in case of damage due to the processing of personal data illegally.

Processing of Personal Data Regarding Application

With the Application Form to the Data Supervisor, limited and linked personal data (name, surname, Turkish ID number, passport number, phone number, e-mail, address, signature) are processed in order to identify the applicant and manage the application. The personal data in question can only be shared with the relevant units / persons and institutions / organizations authorized by law, depending on the nature of the application request.
